Bill Watch Overview

- ✿ **Bill Watch, <http://kentucky.gov/services/billwatch/>, is a free eDemocracy service offered in partnership by the Kentucky Legislature, the Legislative Research Commission and Kentucky.gov.**
- ✿ **Bill Watch connects citizens and businesses interactively with proposed legislation by allowing them to view and track legislation during the Kentucky Legislative Session.**



Overview, contd.

- ✿ **Bill Watch helps remove some of the mystery of lawmaking by adding transparency to the process.**
- ✿ **Bill Watch lets citizens and businesses use the Internet to monitor legislation that matters to them – including health care, education, and taxation bills – without having to spend hours researching legislation with offline sources.**



Bill Watch Features

- ✿ This free online service enables Kentucky.gov registered users unlimited tracking of legislation during the Kentucky Legislative Session.

Specifically, Kentucky.gov registered users can:

- ✿ Create their own profiles that organizes bills by subject or topical area by using search parameters – keywords, sponsors, committees, subject or bill number.

- * View online bill summary, amendments, history and full text details, committee assignment, and most recent action.**

- ▶ Create their own profiles that organizes bills by subject or topical area by using search parameters (keywords, sponsors, committees, subject or bill number) that return a list from which you may select bills to add to your profiles.
- ▶ Receive email notification to their registered email and mobile email account when new bills are offered or changed (from Agenda to Committee to Interim actions) based on the criteria you set up.
- ▶ Bill Tracking is provided online and changes initiate email alert notifications.
- ▶ Search and view online each bill's common title, sponsor(s), committee assignment, and most recent action via search, profile.
- ▶ View online bill summary, amendments, history and full text details, committee assignment, and most recent action.

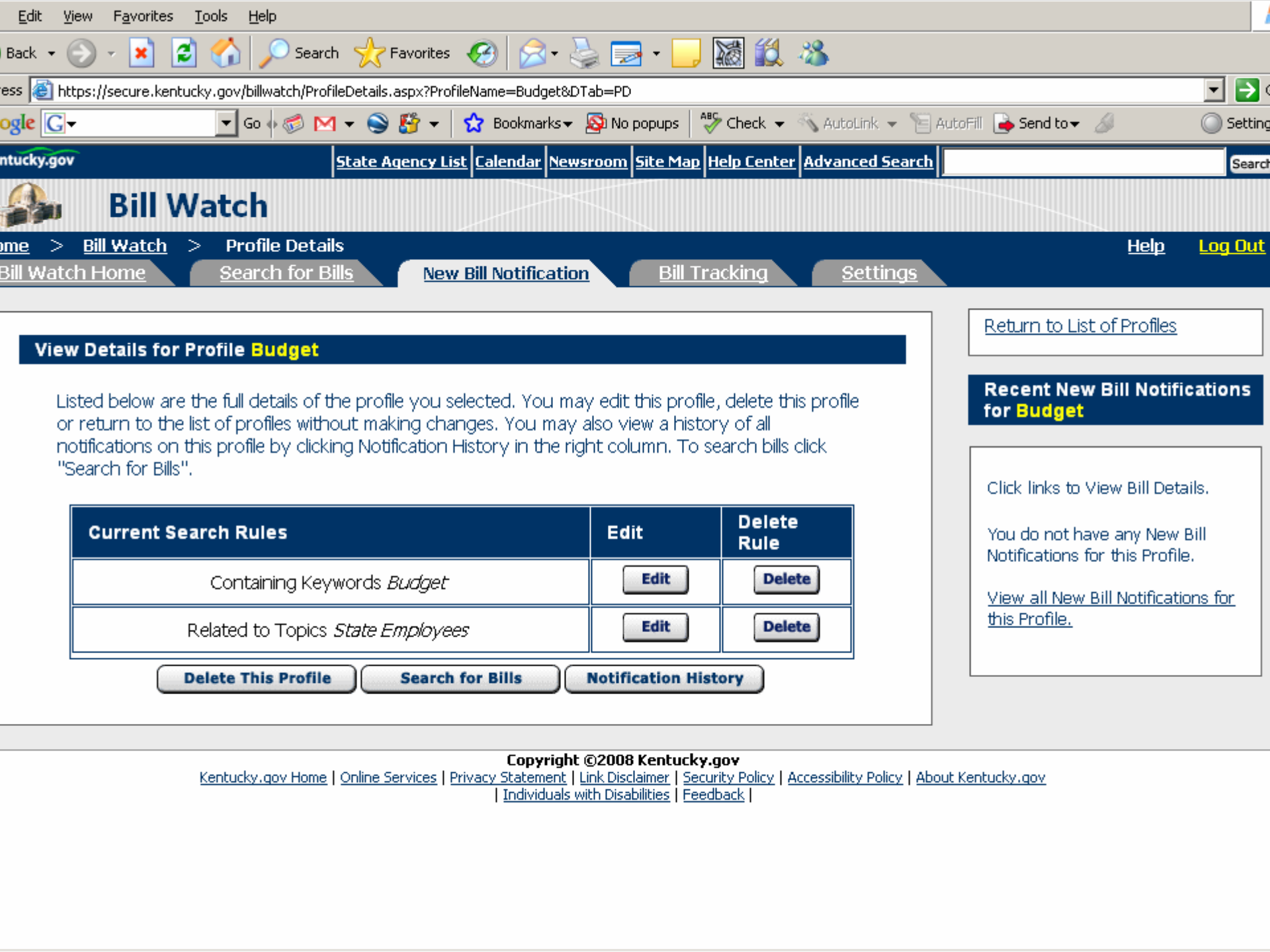
