Legislation Early
Childhood Education
and Care

In January 2012, 31 states have introduced more than 150 bills relating to early childhood education and care issues. Bills focusing on child care issues such as licensing, facilities, subsidies and quality make up the bulk of new legislation introduced, followed by bills pertaining to preschool quality and access

Highlighting a Fellow



On the heels of our kick off meeting in Tampa, Representative Gabel initiated an ongoing group in her district of early childhood stakeholders, which includes agency representatives, coalitions and community foundations to assist in developing legislation. At

the first meeting, she shared with the group information and handouts from our Tampa meeting and of particular interest was the Louisiana model of incentivizing quality. Rep. Gabel knows that Illinois has a strong history in early childhood policy and this group will make sure to understand the policies and activities that already exist. "This group wants to make a difference in improving early childhood," says Gabel. "We don't want to

repeat what has already been done, but more, think of cutting edge policies that can take Illinois to a higher level."

Earlier this month, Rep. Gabel introduced an early intervention bill that would change the definition for eligible infant and toddlers from 36 months to 60 months of age with specified conditions for early intervention services. The proposed bill also allows an individual family service plan to be the child's individualized educational plan (IEP) until an IEP is developed and implemented, if an IEP is not developed by the child's 3rd birthday.
