RE: Land and Water Conservation Fund Permanent Funding Act

Dear Majority Leader McConnell, Speaker Pelosi, Leader Schumer and Leader McCarthy:

On behalf of the National Conference of State Legislatures, the bipartisan organization representing the legislatures of our nation's states, commonwealths and territories, we urge passage of the Land and Water Conservation Fund (LWCF) Permanent Funding Act.

The LWCF supports the protection of federal public lands and waters, including national parks, forests, wildlife refuges, and recreation areas, as well as voluntary conservation on private land. It also provides grants to states for the acquisition and development of public parks and other outdoor recreation sites, to protect and conserve the habitat of threatened and endangered species, and grants to protect environmentally sensitive forest lands. Overall, the LWCF has protected land in every state and supported over 41,000 state and local park projects. Additionally, the LWCF has helped to enhance the outdoor recreation industry, which supports millions of jobs and generates hundreds of billions of dollars in annual consumer spending, while spurring state investment and economic development, and assists with the promotion of healthy lifestyles and efforts to connect youth to the outdoors.

While the LWCF was recently permanently reauthorized, funding for its activities was not made permanent. NCSL supports full, permanent funding of LWCF to ensure that the benefits provided by the LWCF will continue as intended.
